NOTICE OF RACE

The notation [DP] in a rule in the NoR means that the penalty for a breach of that rule may, at the discretion of the Jury, be less than disqualification. The notation (NP) in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a)

1 RULES

- 1.1 The event is governed by the rules as defined in the Racing Rules of Sailing [RRS].
- 1.2 All documents, including any amendments, pertaining to this event are available at *The Official Notice Board* will be located outside the beachmasters office. The office will be at the top of the river slipway.
- 1.3 RYA Post Race Penalty and Arbitration will be available.
- 1.4 Racing rules will be changed as follows:
 - RRS 61.1(a)2 – requirement for protest flag;
 - The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.
- 1.5 Protocols relating to COVID19 may be published at any time and will state if they have the status of a rule.

2 SAILING INSTRUCTIONS

- 2.1 The Sailing Instructions will be available by registration and may also be available on the Association web site beforehand.

3 COMMUNICATIONS

- 3.1 (DP) Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to boats of the GP Fourteen Class whose helm and crew are members of the International GP 14 Class Association.
- 4.2 Eligible boats may enter by completing the attached entry form and submitting it to the GP14 Class Association web site www.gp14.org
- 4.3 The closing date for entries is midnight on **Tuesday August 1st 2023**.
- 4.4 The deposit, adult and youth entry fees are listed in NoR 5 below.
- 4.5 Substitution of the person named as helm on the entry form will not be allowed after registration. See NoR 6 below.
- 4.6 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.7 The following restrictions on the number of boats apply: A maximum of 75 entries will be allowed.

- 4.8 Competitors who are under 18 before and including the last date of the regatta must have a declaration form completed by their parent or guardian before they will be allowed to compete. This applies to helms and crews. The parental declaration form is part of the entry form.
- 4.9 Competitors shall declare their fleet grading when entering. The guidelines for fleet selection are noted on the entry form.

5 FEES

- 5.1 Required fees are as follows:
 Deposit to secure an entry - £30 payable by February 1st 2023
 Full fee for adult helmed boat - £280 up to June 30th 2023, after which a late fee of an additional £50
 Youth helm fee before June 30th - £210, after which a late fee of an additional £50
 Youth helm and Crew before June 30th - £140, after which a late fee of an additional £50.
 (Youth entrant is defined as under 22 years old as at December 31st 2023~)
- 5.2 Cancellation of entry will incur a cancellation cost which is detailed on the entry form and in the additional information section after the end of this Notice of Race.

6. CREW LIMITATIONS

- 6 As detailed in NoR 4.5 substitution of the person named as helm during the event is not allowed after registration. Substitution of the person named as crew during the event will be permitted only with the written permission of the Race Committee.

7 ADVERTISING

- 7.1 Boats may be required to display advertising chosen and supplied by the organising authority. If this rule is broken, World Sailing Regulations 20.9.2 applies [DP].

- 8.1 Competitor Briefing: There will be a briefing for competitors at 8pm Saturday 5th in the club house.
- 8.2 The Championship will consist of a single series of races open to all competitors.
- 8.3 On the last scheduled day of racing the first warning signal of a race will not be made after 14.30 hrs.
- 8.4 The reserve race day (Aug 8th) may be used in the event of bad weather delaying earlier races or a forecast of bad weather jeopardising the schedule later in the week. Notice to competitors, if Tuesday is to be used for, will be published no later than 18.00 on Monday Aug 7th

9 EQUIPMENT INSPECTION

- 9.1 Each boat shall produce a valid measurement certificate at registration. Only certified sails may be used.
- 9.2 All boats are liable to equipment checks on arrival or to be measured at any time during the Championship. The purpose of such inspections is to check the boat's conformity with the Class Rules. Competitors are reminded of their responsibility in the Risk Statement section of this Notice for the condition of the safety of their boat.

10 VENUE

- 10.1 The Championship will be at Looe Sailing Club , 2, Buller Street, West Looe, Looe PL13 1AS.
- 10.2 The Racing area will be on the sea in Looe bay .

11 COURSES

- 11.1 The courses will be defined in the Sailing Instructions.

12 SCORING

- 12.1 Two races are required to be completed to constitute a series.
- 12.2 a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
 - b) When four to seven races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
 - c) When eight or more races have been completed, a boat's score will be the total of her race scores less her two worst scores.

13 SUPPORT BOATS

- 13.1 Support boats will not be permitted.

14 BERTHING

(DP) Boats shall be kept in their assigned places while in the boat park.

15 DATA PROTECTION

Competitors (both helm and crew) will be requested to complete a data protection form at registration. Details are given in the Additional Information section after the end of this Notice.

16 RISK STATEMENT

Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions.
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities.
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather

conditions, as can be practically provided in the circumstances.

- (g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

17 INSPECTIONS

The fact that race officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in this Notice of Race.

18 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per event or the equivalent. Competitors shall sign a declaration to that effect at registration. Insurance is the sole responsibility of the competitors.

19 PRIZES

Trophies and prizes will be awarded to winners of the Championship Prizes may also be awarded to the winners of the Gold, Silver and Bronze fleets. The entry form contains guidelines for selection of fleet and competitors shall nominate their chosen fleet on that form. Other prizes may be awarded at the discretion of the organisers.

3. GDPR – Personal Data permission.
Legislation from May 2018 onwards changes the way in which personal data can be collected, used and destroyed. The Organising Authority (OA) for this Championship will follow the guidelines of the national authority and the Class GDPR policy on www.gp14.org in order to comply with GDPR.

The Personal Data Permission Form, handed to each competitor at registration, covers items such as, but not limited to,
 - taking of photographs and videos for use by the Club or the Class
 - retention of contact data to inform about future events
 - publication of names, clubs and boat numbers on Class web site before the regatta
 - publication of race results during and after the regatta.
4. Details of terms of cancellation
If a competitor wishes to cancel their entry, then;
 - a) Cancellations up to and including June 30th 2023 will be entitled to a full refund of all amounts paid,

- less an administration fee of £30
- b) No refunds will be made after the closing date.
 - c) All notifications of cancellation must be made in writing (an email is sufficient) to the GP14 Class Association office before the date specified above (admin@GP14.org)

If the organising authority implements a decision to cancel under the provisions of NoR 4.10, the amounts to be refunded will match the dates and amounts in 4 a-c above.

Fleet Allocation Guidance

Gold A competitor with aspirations of winning the event. For National/Inland Championships or Grand Prix overall results a competitor would generally have a track record of winning an Area championship or a top 10 position in a UK National Championship or a top 5 position in an Inland Championship.

Silver An experienced dinghy racer with aspirations of finishing in the top half of the fleet. For National/Inland Championships or Grand Prix overall results the sailor may have been successful at open meeting or area level but has yet to finish in the positions described as a Gold fleet sailor.

Bronze A bronze fleet competitor is likely to have a track record of finishing in the bottom half of the fleet or be new to dinghy racing.

1. RISK STATEMENT

It must be recognised that sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the Event, you agree and acknowledge that:

1. (i) You are aware of the inherent element of risk involved in the sport and you accept responsibility exposing yourself to such inherent risk whilst taking part in the Event;
2. (ii) You will comply at all times with the instructions of the Event Co-ordinator particularly with regard to handling of boats, wearing of buoyancy aids and the wearing of suitable clothing for the conditions;
3. (iii) You accept responsibility for any injury, damage or loss to the extent caused by your own negligence;
4. (iv) You will not participate in the Event if your ability to participate is impaired by alcohol, drugs or if you are otherwise unfit to participate;
5. (v) You will inform the Event Co-ordinator if there have been any changes to the information provided on this form at the time of the Event.
6. (vi) The provision of patrol boat cover is limited to such assistance as can be practically provided in the circumstances;
7. (vii) You are aware of any specific risks drawn to your attention by the Event Co-ordinator.
8. The fact that the race Organiser conducts inspection of a boat (for purposes of checking conformity to Class Rules) does not reduce the responsibility of the Boat set out in the Notice of race
9. You have read the NoR section 16 which explains the risks inherent in a racing event.

2. CANCELLATION

You understand that the Event Co-ordinator may cancel or postpone the Event at any stage in the event of bad weather, equipment failure or otherwise. Cancellation terms are explained in the Additional information section of the Notice of race

3. MISCONDUCT

You understand that the Event Co-ordinator may exclude anyone from a particular session and evict anyone from the premises who refuses to comply with these Booking Terms or who misconducts themselves in any way or who causes damage or annoyance to other persons.
