## **Booking Terms**

### **1. Risk Statement for the cruising week event at Red Wharf Bay Sailing & Boating Club. 2025**

It must be recognised that boating is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, you agree and acknowledge that;

- i. You are aware of the inherent element of risk involved in the sport and you accept responsibility exposing yourself to such inherent risk while taking part in the event.
- ii. You will comply at all times with the instructions of the event organiser particularly with regard to handling of boats, wearing of buoyancy aids/life jackets and the wearing of suitable clothing for the conditions.
- iii. You accept responsibility for any injury, damage, or loss to the extent caused by your own negligence.
- iv. You will not go afloat if under the influence of alcohol, drugs or if otherwise unfit to participate.
- v. The provision of safety boat cover is limited to such assistance as can be practically provided in the circumstances.
- vi. You certify your suitability for the event and that your boat is equipped as a minimum to GP14 Association cruising essential safety requirements (**see Appendix 3**)
- vii. You will inform the event organiser if there have been any changes to the information provided on this form.

### **2. Event Fees**

You agree to make payment for entry to the event and/or other Club/Association charges as may reasonably be required for the event duration.

### **3. Cancellation**

You understand that the organiser may cancel or postpone the cruising event at any stage in the event of bad weather, venue complications or otherwise.

### **4. Misconduct**

You understand that the event organiser may exclude anyone who refuses to comply with these Booking Terms or who misconducts themselves in a manner inconsistent with the Constitution of the International GP14 Class Association.

### **5. Data Protection**
